- No temporary structure such as tents or with thatched construction should be allowed for educational institutions.
- Emergency power generator etc., and associated equipment should be tested periodically and verified as per NBC, and IS-1646.
- Every room with a capacity of 45 students (for educational building) shall be maintained obstruction free minimum two doorways.
- Every vertical opening between the floors of the building shall be suitably
  enclosed or protected to prevent spread of fire, smoke and fumes from one floor
  to other.
- Evacuation plan at showing exit routes and recommended action plan be displayed at conspicuous locations and shall be exhibited all times, all escape /exit routes shall not be blocked or encroached.
- Fresh NOC would be required for any change in occupancy or additions/ alterations in the building structure as per NBC of India and building bye-laws.
- The Management has to maintain Fire Safety Measures at all times in good working Condition as seen during the inspection.
- Any Loss of life or property due to Non functioning of Fire Safety Measures and other installations shall be the responsibility of the management/owner.
- All the Occupants must know the correct method of operation of the First Aid Fire Fighting System installed.
- All Security personnel shall be trained to operate the Fire Safety Equipment during the Emergency.
- Orders will be issued without any prejudice to take action against the Unauthorized construction if any made.
- 14. This Renewal of Fire No Objection Certificate is valid for one year from the date of issue and it is the responsibility of the builder/occupier to apply for the next renewal, two months before the expiry of this Renewal of Fire NOC.
